Ok. So let me give you a littler perspective on what happened today. I was in bed sleeping when my lawyer called me to let me know what happened.

I did not show up in court. Because of that the judge issued a \$500 civil bench warrant. So if I ever come to Santa Clara County and get pulled over for say speeding, it would get served and I would have to pay \$500.

And that's it.

\$500 is how much a parking ticket costs in California. Due to surcharges and court fees, all added onto the ticket, it comes to around \$500.

It was the smallest amount the judge could do.
