### **DECLARATION OF SUSAN BASKO**

- 1. My name is Susan Basko. I am a grandma and a lawyer licensed in Illinois and California. I live thousands of miles outside of California. My California bar number is 230396.
- 2. I am not able to make it to court and would not ever be able to make it, due to poor health, financial restrictions, not having the free time, and being very far away.
- 3. I have not been served with any papers in this case and have not seen any court filings.
- 4. I can be called by the court at 310-770-7413. I can be emailed by the court at suebasko@gmail.com
- 5. I DO NOT WANT ANY CONTACT. I have never met Mr. Leiderman and have never spoken with him on the phone. I try to avoid him and have him blocked on all social media. It distresses me greatly to have him emailing me, even about this restraining order. He keeps filing court cases against me, it seems, because he wants to have contact with me. This is the 4<sup>th</sup> time now that Mr. Leiderman has gone into court with conspiracy theories and tales that I am trying to kill him or harm him in some way. Absolutely none of it comports with reality. As stated, I am a really nice person and grandma and lawyer living thousands of miles away, just wanting this man to leave me alone.
- 6. NOT DOING ANYTHING WRONG. I avoid contact with Mr. Leiderman. I do not contact him and have given him several sets of DO NOT CONTACT notices over the past year. I have never met Mr. Leiderman and have never spoken with him on the phone. I have never threatened Mr. Leiderman. I am not involved in any group or activity to harm or kill Mr. Leiderman and am not aware of any such thing. All my actions are peaceful and legal.
- 7. KEEPS DOING THIS. Mr. Leiderman sought this same restraining order a few days ago on Sept 26, 2014. Nothing has changed in the meantime. I still do not want any contact with Mr. Leiderman, I am still not a terrorist or in any conspiracy, I am still busy with my life and work thousands of miles away, I still do not know of anyone trying to kill or hurt Mr. Leiderman. It is the 4<sup>th</sup> time Mr. Leiderman has run into court claiming I am trying to kill him. This is taking up huge amounts of my time, my money, and is destroying my health and my life. I have told Mr. Leiderman several times that if he thinks I am trying to kill him (from thousands of miles away, no less) to please call the police and report it.

- 8. HIS GOAL IS TO HARM MY LAW LICENSE. Mr. Leiderman's goal in trying to get a restraining order is to harm my law license. He has been attacking me and my profession of law for over a year now. I am a wonderful lawyer ethical, good, kind, caring, moral, and doing work that changes lives and society for the better. Mr. Leiderman knows that if he can get a restraining order, he can parlay this to damaging my law license. That is his goal.
- 9. WITNESS INTIMIDATION. Mr. Leiderman appears to be in some sort of trouble for allegedly breaching the private email accounts of two lawyers in the Ventura Public Defenders Office. See EXHIBIT A, which shows an email to me from Michael McMahon, the Deputy Public Defender in the Ventura Public Defenders office. apologizing that Mr. Leiderman used their emails and saying this was inappropriate. Mr. Leiderman then sent me the email shown in EXHIBIT B, in which he makes the outrageous and false assertion that I am in some sort of inappropriate contact with people or agencies, and belittles and demeans me and my work, and tries to intimidate me as a witness from participating in an investigation into his actions. I am not aware of such an investigation, but it sounds as if Mr. Leiderman is aware of one and is trying to intimidate me from participating. By filing this application for a restraining order, Mr. Leiderman is trying to intimidate me as witness with regard to this. Whatever investigation is taking place, if any is, is not under my control, seeing as how I am not an investigator and they were not my email accounts that were allegedly breached, but those of the Ventura Public Defender's office. If I am asked to give information or to testify in any such investigation, if there is one, I will do so. I do not want to be intimidated as a witness by Mr. Leiderman filing for a restraining order to try to keep me from participating in any such investigation, if there is one.
- 10. NOT AWARE OF INVESTIGATION. I am not aware of such an investigation taking place into Mr. Leiderman's alleged breach into the private email accounts of two lawyers in the Ventura Public Defenders Office. If such an investigation is taking place and I am called to give information or testimony, I will, and I do not want Mr. Leiderman to keep intimidating me about this.
- 11. EXTREME WITNESS INTIMIDATION. Mr. Leiderman asking for a restraining order against me as a lawyer is extreme witness intimidation. I am a very good, ethical lawyer. I earned my law degree at an older age, graduating magna cum laude. I am licensed in two states and use my law licensed to do a real lot of good to help people and society. Mr. Leiderman keeps attacking me and my profession of law.
- 12. EXHIBITS: Mr. Leiderman allegedly sent me the emails shown in Exhibits C and Exhibit D. These came from private email accounts of lawyers in the Ventura public defender's office, Nicholas Gray and Paul Baelly. The emails seemed to be giving some sort of notice, but did not say about what or whom or give a date or case name. I contacted the Ventura Public Defender's office to ask what this was all about. The Deputy Public Defender, Michael McMahon, sent me the email shown in EXHIBIT A. In that email, Michael McMahon apologized and stated that it was inappropriate for Mr. Leiderman to use their emails. In EXHIBIT B, this is a copy of an email where Mr.

Leiderman is intimidating me as a witness from participating in any investigation, if I should be called upon to do so. EXHIBIT D shows an email from Mr. Leiderman where he says he is holding a TRO hearing October 3. Exhibits E, F, and G are the original coding on the emails that show their authenticity and origin. I STATE UNDER penalty of perjury under the State of California, through my signature on this document, that the attached exhibits are true and accurate copies of the emails I have received and of the original coding connected to them.

- 13. ABUSIVE. Mr. Leiderman is an "emotional battering" type of abuser in that he has posted publicly online hundreds of times demeaning me and my work, lying about me outlandishly, has attacked me and my law licenses repeatedly, and all this even though I avoid him, am not involved with him in any way, and my work and life are not any of his business. I do not do anything to Mr. Leiderman, other than occasionally defending myself from his malicious attacks, such as when he has gone into court claiming I am trying to kill him and other such bizarre and damaging nonsense. Mostly, I ignore what he does, block him on social media, and report some of his actions to social media and to law enforcement agencies, if appropriate. Mr. Leiderman has absolutely no relationship with me, and yet continuously makes up sordid fantasies of his own imagining, and tries to monitor, control, and dictate my life. This TRO application is yet another example of this.
- 14. NO ONE UNDER MY CONTROL. There is no one who is acting at my control or direction. I am not acting under anyone's control. I have no influence or control over anyone else's actions.
- 15. NO CONSPIRACY. I pay very little to no attention to what others are doing. I am not responsible for anyone else's' actions. I am not aware of or involved with any other person or group or anything they might be doing.
- 16. BUSY. I am EXTREMELY busy with my work, which is socially important and interesting and fulfilling, and with my dear family and friends.
- 17. SOCIAL MEDIA. Unlike Mr. Leiderman, I spend very little time online on social media. My accounts are locked or private and I rarely make posts and do not have time to read much of what others write. Mr. Leiderman continually posts publicly online his strange and false statements about my ideas, my actions, my associations, and my work, although he has no knowledge of these things. He has no idea with whom I associate, who my family is, where I am, what I am doing, what my work is, what I think. I have given Mr. Leiderman DO NOT CONTACT notices to stop mentioning me on his social media accounts, but he scoffs at these. I do not "follow" Mr. Leiderman's accounts, but people compile his abuses and email them to me. I NEVER post publicly anything about Mr. Leiderman, except on rare occasion to defend myself against his bizarre, false court filings by stating the truth that I am a good lawyer and not involved with Mr. Leiderman in any way.

- 18. VICTIM OF EXTREME ABUSE. I am a victim of extreme stalking and abuse at the hands of Mr. Leiderman and his client, James McGibney, and several of their associates. Ironically, I am being victimized further here by my stalkers. I do absolutely nothing to them, so there is no evidence of me doing anything. They are harassing me in this way to cause me harm and specifically because they want to get a court order against me to try to cause me to lose my law license. I am a wonderful, good, kind, ethical, caring lawyer and person. I am very tired and worn and sick from being stalked and harassed by these men for almost a year now.
- 19. NO CONTACT. I do not have contact of any kind with Mr. Leiderman or any of his clients, so it is dishonest and bizarre for him to seek a restraining order. I have never met Mr. Leiderman. I have never phoned Mr. Leiderman. I do not engage in any sort of communication or contact with Mr. Leiderman. I really want to be left alone. I strongly dislike Mr. Leiderman and consider him dangerous and dishonest, and want no contact of any kind with or from him. Mr. Leiderman has continually tried to harm me, harm my law license, and harm my work. He seems unable to simply leave me alone. He has twice already filed bizarre court filings in cases where I am not even a party in order to try to make me lose my law license or get me in legal trouble. People ask why I have not filed for a restraining order against him and the answer is that I do not want even the contact of going into court with him.
- 20. IN CONSIDERING THIS, I urge the court to make note that Mr. Leiderman has no evidence of me doing anything wrong, since none exists. Since I have not seen any paperwork, I do not know if he may have falsely created something. Also, I urge the court not to believe ANYTHING Mr. Leiderman says, as I have seen a court transcript from May 12, 2014, in the case of Via View v Retzlaff in County of Santa Clara, where Mr. Leiderman went into court and told the most shocking lies about me and about others. When he says something, even the most mundane things, I urge the court to make him prove it. For example, at the May 12 hearing, Mr. Leiderman claimed I am in a "Manson-like" conspiracy to kill him. Mr. Leiderman also claimed that a man named Joseph Camp was going to prison for "10 to 20 years" for "hacking," when the truth was that Mr. Camp had taken a plea deal of 5 months for a parole violation of staying out late. PLEASE MAKE MR LEIDERMAN prove every tiny thing he says, as he is trying to ruin my life and destroy my legal profession with his lies.
- 21. DO NOT RESPOND OR REPAY. Although I have been extremely stalked by Mr. Leiderman, I do not respond and have not repaid him in like kind. I DO report his wrongful actions to the authorities and to law enforcement agencies, but I do not engage in similar actions back at him, and never have.
- 22. BLOCKED. I have blocked Mr. Leiderman from my Twitter account (which is a locked account @suebasko), from my Facebook account, on which he was stalking me as a "friend of a friend." I want no contact of any kind from or with Mr. Leiderman, or anyone associated with him, at any time.

- 23. NOTICE: I have seen no paperwork in this case. However, since Mr. Leiderman for months has been claiming all sorts of wildly insane conspiracy theories against me, I shall assume this is the same bizarre conspiracy theory that Mr. Leiderman keeps claiming, and will address it as such.
- 24. It is my opinion, as a lay observer, that Mr. Leiderman is severely mentally ill. I have received emails from Mr. Leiderman where he claims I am a terrorist in a conspiracy to kill him. Mr. Leiderman claims I am in a conspiracy with people I do not know and to whom he attributes all sorts of lurid things. Mr. Leiderman has sent me emails where he tells me I am a terrorist who must turn myself in to authorities by a certain time and beg their mercy. This is all really wild considering I am a peaceful, law abiding, happy friendly grandma and good lawyer a few thousand miles away.
- 25. MY LEGAL WORK for Media: I am a lawyer for independent media. I help people with contracts and advice and trademarks, copyrights, etc., for music, film, video, journalism, books, websites, designers, clothing design, and other creative ventures. I also advise on computer and internet law. I have several blogs where I give useful information on these topics. The main blog is <a href="http://suebasko.blogspot.com">http://suebasko.blogspot.com</a> This blog gets many readers and many of them email me with legal questions. I love helping the public. I also answer legal questions from the public on Law Q&A, where I have accounts for both Illinois and California. - 26. MY LEGAL WORK FOR PUBLIC assembly: Another aspect of my legal work is international work on peaceful public assembly, such as protest. I have helped groups plan peaceful public assembly / protest nationally. I have also assisted with the study, planning, and legal recommendations for public assembly worldwide with OSCE-ODIHR, the Organization for Security and Cooperation in Europe, Office of Democratic Institutions and Human Rights, in Vienna, Austria. OSCE has 70+ member nations and is sort of like the U.N., but based in Europe. As such, I am involved in diplomatic type relations with people from many nations.
- 27. MY LEGAL WORK with the DISABLED: I have assisted numerous people who have mental disabilities or who have differing abilities, with conditions such as mental illness, autism, traumatic brain injury, memory loss, etc. The people I assist are in serous trouble, usually with pending state or federal criminal charges or having been raided by the FBI. I volunteer as a liaison between the disabled people and their families and the legal system, to help them get the needed mental health and medical care and sometimes to help them find lawyers. This work is very fulfilling for me. I am helping people who are in dire need. An example of this work is that I helped a man who was not being given a public defender in a jail because he was required to fill out a form, but was so mentally ill that he could not fill it out. I liaised with the public defender office and got him a lawyer. Then, I advocated for him to get mental health care while in custody. He is now mentally well and stabilized and is finally home with his parents after 2 years in custody. I do this as a volunteer and there has been a steady flow of those in need being sent to me.

- 28. LEIDERMAN INTERFERING WITH MY PROFESSION OF LAW: For about the past year, Mr. Leiderman has maliciously interfered with my legal work by harassing me, posting defamation and denigration about me and my work online, sending me denigrating emails where he mocks me, posting my personal and private emails online, stalking me online, etc. Mr. Leiderman has also colluded with one of his clients and weird malicious sock puppet unnamed people trying to get me to lose my law license by filing malicious, defamatory and bizarre bar complaints against me and posting the same online. I will make a list of the things he has done to me later in this document.
- 29. HOW MR LEIDERMAN BEGAN STALKING AND HARASSING ME: In about January 2014, Mr. Leiderman and his pals were participating in vicious online harassment of a young man named Joseph Camp. Mr. Camp has special needs and disabilities and was just out of prison where he had taken a plea deal on a charge of hacking computers at his college. Joseph Camp was being particularly malicious stalked by a twitter account called @mybronyninja, that identified Jay Leiderman as its lawyer. Joseph Camp faxed to Mr. Leiderman a 35-page pdf containing a list of some of the malicious tweets against Joseph Camp that were posted by @mybronyninja. Rather than have empathy for this disabled young man who was being terribly harassed, Mr. Leiderman instead filed a false police report against Joseph Camp, claiming that Joseph Camp sent him a 3,000 page fax. Since I am licensed in California, I offered to help Joseph Camp with the police report. The police investigated and no charges were filed. Mr. Leiderman was enraged that I dared to help Mr. Camp, and began maliciously stalking and attacking both me and the young man. Mr. Leiderman took delight in posting on Twitter and on his blog gloatingly calling the young man a "CONVICTED" FELON," posting the name of the young man's foster mother and parole officer, urging Leiderman's troll and idiotic "followers" to contact and harass these people and on and on. Mr. Leiderman has stalked that young man and stalked me ever since.
- 30. Mr. Leiderman filed court papers in two court cases where I am not a party, trying to have me held in contempt of court by claiming I am in a conspiracy to kill him. The names of the cases where Mr. Leiderman filed these papers are Via View v Retzlaff and Via View v Camp. Both of these were workplace violence TRO cases against men who had never had any contact with Mr. Leiderman, who have stated they have never been to California. In both of those cases, it was obvious Mr. Leiderman's main purpose was to try to control the online free speech of those men. One of these was the aforementioned Joseph Camp and the other was Thomas Retzlaff. Mr. Retzlaff is a man I do not know and with whom I have had no contact.
- 31. LEIDERMAN'S CONSPIRACY THEORIES. On May 12, 2014, Mr. Leiderman went into Superior Court of California, County of Santa Clara, in the case of Via View v Retzlaff. I was not present in court, but later was given a copy of the transcript. Although I am not a party in the case, Mr. Leiderman filed a bizarre court paper trying to have me held in contempt of a court order, although there is no court order against me. Mr. Leiderman was claiming that I was in a conspiracy with Thomas Retzlaff, a man I do not

know and with whom I have never had contact. Mr. Leiderman was claiming that we were in a "Manson-like" conspiracy to kill him.

- 32. LEIDERMAN CONSPIRACY THEORY REGARDING THOMAS RETZLAFF: Mr. Leiderman has repeatedly stated, written, and told courts that I am in conspiracy with a man named Thomas Retzlaff. I do not know Thomas Retzlaff and have had no contact with him. There is no conspiracy. I have seen many instances online where Mr. Leiderman has posted hateful statements about Mr. Retzlaff, attributing outlandishly lurid things to him. Since Mr. Leiderman has posted a huge number of lies about me, I do not believe anything he says about anyone.
- 33. LEIDERMAN CONSPIRACY THEORY REGARDING NEAL RAUHAUSER: Mr. Leiderman has repeatedly stated, written and told courts that I am in a conspiracy with a man named Neal Rauhauser. I do not know Mr. Rauhauser. I have seen online that Mr. Rauhauser is an infodata researcher and seems very highly intelligent. I have had a few small professional type interactions online with Mr. Rauhauser. There is no conspiracy. I have also seen online where Mr. Leiderman has posted huge amounts of scurrilous attacks against Mr. Rauhauser, and Mr. Leiderman has written the same sort of slurs in his court filings and spoken them in court. Since Mr. Leiderman has posted a huge number of lies about me, I do not believe anything he says about anyone.
- 34. LEIDERMAN CONSPIRACY THEORY REGARDING JOSEPH CAMP. Mr. Leiderman has repeatedly stated, written, and told courts that I am in a conspiracy with Joseph Camp. Joseph Camp is a young man with special needs, from New York state, who was my legal client for a short time for the limited purpose of addressing a false police report filed against him by Mr. Leiderman. Mr. Camp is not my client now and I have little to no contact with him. During the time Mr. Camp was my client, and at all times, my relationship with Mr. Camp has been of the highest caliber of professionalism and ethics. Mr. Leiderman created and spread lies that Mr. Camp was doing something improper for me for pay. Mr. Camp has never done anything for me and I have never paid him. In dealing with Mr. Camp, I always implored him to follow my lead and block and report people who do wrong, but not to repay them in like kind. He may not always have followed this, but that was the message he always got from me.
- 35. I am in little to no contact with Joseph Camp. I am not his lawyer at this time. I do not pay attention to what Mr. Camp is doing, as it is none of my concern. Mr. Camp cannot be contacted through me. I have at no time had any influence or control over Mr. Camp, though I always try to set a good example by doing what is good and right.
- 36. JOSEPH CAMP'S WEBSITE: Mr. Leiderman also created and spread a lie that I am in control of Joseph Camp's website. This is entirely untrue. Mr. Camp collects documents that he gets through FOIA requests and through research. He posts those on his website. I have only ever been able to see the first page of Mr. Camp's website, because my computer browser is outmoded and is incompatible with the site, so my browser crashes each time I go to the site.

- Mr. Leiderman's belief that I control the site was based on at one time, I thought I had the password for the site and offered to remove something from the site that a person said bothered them. I told that person to let me know where the item was on the site and IF I could access the site, I would remove it. The person was mistaken, as there was no such item on the site. And, as it turned out, I was not able to access the site, since merely going to it crashed my browser. MR. LEIDERMAN was told many times that I have never had access to the website, but he continues to harass me about it and spread lies. ASIDE from which, Mr. Camp's website belongs to Mr. Camp, and it is unclear why Mr. Leiderman should have any concern with it.
- 37. VIA VIEW FILES BLOG. Mr. Leiderman dislikes a blog called Via View Files or BV Files. That is not my blog. I do not own it, administer it, or write it.
- 38. Mr. Leiderman has a client named James McGibney. Mr. McGibney runs a corporation called Via View. In my opinion and by observation, Via View runs an extortion racket. McGibney runs a revenge porn website called Cheaterville.com where he posts the often-compromising or sex photos of people, along with scurrilous writings about them. The victims of the site are then supposed to pay extortion fees of hundreds of dollars to have their photos and listings removed.
- 39. James McGibney also runs a hate speech/ extortion site called Bullyville.com. Mr. McGibney has posted huge amounts of defamation against me, and invasions of my privacy, stalking, harassment, etc. on his Bullyville.com site. Mr. McGibney also has tweeted many sexual and stalking and taunting tweets at me.
- 40. Mr. McGibney purchases domain names in the names of people he is harassing or trying to extort. Mr. Leiderman appears to approve of and encourage this method of harassment by Mr. McGibney. In my name, Mr. McGibney owns Suebasko.com, suebaskolaw.com, and disbarbasko.com. He uses these to defame, denigrate, demean, and to try to extort me.
- 41. LEIDERMAN AND MCGIBNEY ASSOCIATE WITH MALICIOUS PEOPLE ONLINE. Mr. Leiderman and Mr. McGibney associate online with two particularly malicious people. One of these people uses the sock puppet names of @CattyIdiot, who runs a racist radio show called "Tea Time for Jew and Me," and engages in a huge amount of racism, anti-Semitism, sexism, ageism, and constant, shockingly malicious attacks against others. The other associate of Mr. Leiderman and Mr. McGibney uses the name "Captien Obvious" or "Captien 007." Both of these unnamed individuals have stalked and harassed me, engage in a constant effort to try to get me to lose my law license and undermine my work. "Captien Obvious" wrote and posted a ludicrous, unsigned bar complaint against me and Mr. Leiderman filed it, though claiming not to know who Captien Obvious is.
- 42. ASIDE from the above-named two extremely malicious people, Leiderman and McGibney also associate with many other malicious people from the hacker group Anonymous, the hacker-fraudster group Rustle League, and McGibney's harassment-

vigilante gang called Bullyville. I want NO contact from or connection with such people and I block them, ignore them, and report them to social media abuse departments when needed.

- 43. NEVER HAD CONTACT WITH MCGIBNEY, CATTY IDIOT, OR CAPTIEN OBVIOUS. I have never met, contacted, responded to, or engaged in any sort of contact or reaction to Mr. McGibney or his associates, Catty Idiot or Captien Obvious. This is true, despite the ongoing, horrifically vulgar, sickening, disgustingly sexualized filth, attacks on my character, attacks on my work, denigrations against me, posted continuously by these perverts online. I simply report them to social media, report them to authorities, block them, and ignore them.
- 44. MY PRIVATE EMAILS POSTED PUBLICALLY ONLINE. Mr. Leiderman got ahold of a good number of my private personal and legal emails. Each one was marked with a privacy notice. Mr. Leiderman immediately posted my emails online for all the world to see. So did Mr. McGibney, Cattyldiot, and Captien Obvious. ALL of these emails were of a deeply private nature. When I asked Leiderman and McGibney to stop posting my emails, they posted more and mocked me.

When I wrote an email to Paul Gianni, a lawyer in Texas doing some work for McGibney's revenge porn/extortion company, Via View, and asked him to please get Leiderman and McGibney to take my private emails down from public view, Leiderman and McGibney posted that email and mocked and taunted me.

When I wrote an email to a Via View Board member, Scott Corey Ryan, who is also licensed in Illinois and who may have been my law school classmate, to please have them remove my private legal and personal emails from public display, Leiderman replied to me and to Mr. Ryan calling me mentally ill and a terrorist.

Mr. Leiderman and Mr. McGibney got the private emails that they posted by various means: from my legal correspondence with Mr. Leiderman, Mr. Gianni, and Mr. Ryan; through an illicit subpoena in a nonexistent court case, sent to a woman colluding with Mr. McGibney and his extortion/ revenge porn, and a whole group of emails were hacked from the account of a radio show host of a show where I appeared once as a guest.

"Captien Obvious" then wrote a bar complaint against me, that was filed by Mr. Leiderman, accusing me of being unethical because I objected to them hacking private emails and posting them online. As proof of my being "unethical," he included an exhibit of one of my private, hacked emails where I was complaining about my emails being hacked and posted online. Mr. Leiderman thought this was a worthy bar complaint and filed it with the California Bar.

- 45. Mr. Leiderman and Mr. McGibney have done the following things, and many other very bad things, to me, including:
  - i. Posted my private emails online
  - ii. Harassed me nonstop

- iii. Created conspiracy theories about me
- iv. Filed false court papers about me in cases where I am not a party
- v. Tried to have me held in contempt of court on non-existent court orders.
- vi. Lied in court about me
- vii. Bought at least 3 domains in my name and used them to defame, stalk, harass, demean, and damage me personally and professionally: Suebasko.com, suebaskolaw.com, disbarbasko.com. McGibney owns dozens of domains in the names of people he is stalking and extorting.
- viii. Created malicious and defamatory websites against me
- ix. posted malicious and stalking things about me on McGibney's website Bullyville.com and on other horrifyingly malicious websites such as Encyclopedia Dramatic and on the crime tor site Doxbin, which posts peoples' personal information such as social security numbers, bank number, etc..

- 48. LEIDERMAN TYING ME TO HIS CONSPIRACY THEORIES. Because, as I have stated repeatedly, I do nothing to Mr. Leiderman or Mr. McGibney, they have created wild conspiracies where they claim I am in (nonexistent) conspiracies with men to whom they attribute all sorts of lurid things. I don't do anything, so Leiderman tries to claim I

do something by linking me by conspiracy to men whom Leiderman denigrates, although I don't think those men are doing anything wrong, either.

- 49. EXTREME DAMAGE TO ME. The stalking and harassment I have endured from Mr. Leiderman, Mr. McGibney, and their associates "Catty Idiot" and "Captien Obvious" have been extreme. ## **DECLARATION OF SUSAN BASKO**

- 1. My name is Susan Basko. I am a grandma and a lawyer licensed in Illinois and California. I live thousands of miles outside of California. My California bar number is 230396.
- 2. I am not able to make it to court and would not ever be able to make it, due to poor health, financial restrictions, not having the free time, and being very far away.
- 3. I can be called by the court at 310-770-7413. I can be emailed by the court at <a href="mailto:suebasko@gmail.com">suebasko@gmail.com</a>
- 4. VICTIM OF EXTREME ABUSE. I am a victim of extreme stalking and abuse at the hands of Mr. Leiderman and Mr. McGibney and several of their associates. Ironically, I am being victimized further here by my stalkers. I do absolutely nothing to them, so there is no evidence of me doing anything. They are harassing me in this way to cause me harm and specifically because they want to get a court order against me to try to cause me to lose my law license. I am a wonderful, good, kind, ethical, caring lawyer and person. I am very tired and worn and sick from being stalked and harassed by these men for almost a year now.
- 5. NO CONTACT. I do not have contact of any kind with Mr. Leiderman or any of his clients, so it is dishonest and bizarre for him to seek a restraining order. I have never met Mr. Leiderman. I have never phoned Mr. Leiderman. I do not engage in any sort of communication or contact with Mr. Leiderman. I strongly dislike Mr. Leiderman and consider him dangerous and frightening, and want no contact of any kind with or from him or anyone associated with him. Mr. Leiderman has continually tried to harm me, harm my law license, and harm my work. He seems unable to simply leave me alone. He has twice filed bizarre court filings in cases where I am not even a party in order to try to make me lose my law license or get me in legal trouble. Mr. Leiderman is malicious, dishonest, and dangerous. People ask why I have not filed for a restraining order against him and the answer is that I do not want even the contact of going into court with him.

There is no cause whatever for a restraining order, since I adamantly refuse to have any contact or communication with Mr. Leiderman and / or with ANYONE who associates with him in any way. I ask the court to DENY all of Mr. Leiderman's requests and dismiss this case with prejudice.
- 8. Mr. Leiderman has stalked and harassed me extremely for about one year. I have given him DO NOT CONTACT notices. I will make a list below of some of the things he has done to stalk me.
- 9. DO NOT RESPOND OR REPAY. Although I have been extremely stalked by Mr. Leiderman, I do not respond and have not repaid him in like kind. I DO report his wrongful actions to the authorities and to law enforcement agencies, but I do not engage in similar actions back at him, and never have.
- 10. BLOCKED. I have blocked Mr. Leiderman from my email accounts, Twitter account (which is a locked account @suebasko), from my Facebook account, on which he was stalking me as a "friend of a friend." I want no contact of any kind from or with Mr. Leiderman, or anyone associated with him, at any time.
- 11. NOTICE: I was not given proper notice of this hearing. A couple nights ago, Mr. Leiderman apparently entered the Ventura County Public Defenders Office where he was formerly employed, illegally accessed the email accounts of two of the lawyers who work there, and used those accounts to send me mysterious emails saying "we" are seeking a restraining order, but not stating what it was about or who the person might be that needs a restraining order against me. I include those emails as Exhibit A and Exhibit B. After receiving these strange emails, I wrote to the Public Defenders office and received the attached email, Exhibit C, in which the office acknowledges it was Mr. Leiderman who accessed their lawyers' private email accounts and used them to send me the strange emails. I state under penalty of perjury that these Exhibits A, B, and C are true and accurate copies of the emails I received.
- 12. NOTICE: Since I absolutely avoid Mr. Leiderman and everyone who associates with him, these email "notices" left me perplexed. As I write this, I still do not know the name of this case, do not know who might be claiming to need a restraining order, and have seen no paperwork.

- 13. NOTICE: However, since Mr. Leiderman for months has been claiming all sorts of wildly insane conspiracy theories against me, I shall assume this is the same bizarre conspiracy theory that Mr. Leiderman keeps claiming, and will address it as such.
- 14. It is my opinion, as a lay observer, that Mr. Leiderman is severely mentally ill. I have received emails from Mr. Leiderman where he claims I am a terrorist in a conspiracy to kill him. Mr. Leiderman claims I am in a conspiracy with people I do not know and to whom he attributes all sorts of lurid things. Mr. Leiderman has sent me emails where he tells me I am a terrorist who must turn myself in to authorities by a certain time and beg their mercy. This is all really wild considering I am a peaceful, law abiding, happy friendly grandma and good lawyer a few thousand miles away.
- 15. MY LEGAL WORK for Media: I am a lawyer for independent media. I help people with contracts and advice and trademarks, copyrights, etc., for music, film, video, journalism, books, websites, designers, clothing design, and other creative ventures. I also advise on computer and internet law. I have several blogs where I give useful information on these topics. The main blog is <a href="http://suebasko.blogspot.com">http://suebasko.blogspot.com</a> This blog gets many readers and many of them email me with legal questions. I love helping the public. I also answer legal questions from the public on Law Q&A, where I have accounts for both Illinois and California. - 16. MY LEGAL WORK FOR PUBLIC assembly: Another aspect of my legal work is international work on peaceful public assembly, such as protest. I have helped groups plan peaceful public assembly / protest nationally. I have also assisted with the study, planning, and legal recommendations for public assembly worldwide with OSCE-ODIHR, the Organization for Security and Cooperation in Europe, Office of Democratic Institutions and Human Rights, in Vienna, Austria. OSCE has 70+ member nations and is sort of like the U.N., but based in Europe. As such, I am involved in diplomatic type relations with people from many nations.
- 17. MY LEGAL WORK with the DISABLED: I have assisted numerous people who have mental disabilities or who have differing abilities, with conditions such as mental illness, autism, traumatic brain injury, memory loss, etc. The people I assist are in serous trouble, usually with pending state or federal criminal charges or having been raided by the FBI. I volunteer as a liaison between the disabled people and their families and the legal system, to help them get the needed mental health and medical care and sometimes to help them find lawyers. This work is very fulfilling for me. I am helping people who are in dire need. An example of this work is that I helped a man who was not being given a public defender in a jail because he was required to fill out a form, but was so mentally ill that he could not fill it out. I liaised with the public defender office and got him a lawyer. Then, I advocated for him to get mental health care while in custody. He is now mentally well and stabilized and is finally home with his parents after 2 years in custody. I do this as a volunteer and there has been a steady flow of those in need being sent to me.

- 18. LEIDERMAN INTERFERING WITH MY PROFESSION OF LAW: For about the past year, Mr. Leiderman has maliciously interfered with my legal work by harassing me, posting defamation and denigration about me and my work online, sending me denigrating emails where he mocks me, posting my personal and private emails online, stalking me online, etc. Mr. Leiderman has also colluded with one of his clients and weird malicious sock puppet unnamed people trying to get me to lose my law license by filing malicious, defamatory and bizarre bar complaints against me and posting the same online. I will make a list of the things he has done to me later in this document.
- 19. HOW MR LEIDERMAN BEGAN STALKING AND HARASSING ME: In about January 2014, Mr. Leiderman and his pals were participating in vicious online harassment of a young man named Joseph Camp. Mr. Camp has special needs and disabilities and was just out of prison where he had taken a plea deal on a charge of hacking computers at his college. Joseph Camp was being particularly malicious stalked by a twitter account called @mybronyninja, that identified Jay Leiderman as its lawyer. Joseph Camp faxed to Mr. Leiderman a 35-page pdf containing a list of some of the malicious tweets against Joseph Camp that were posted by @mybronyninja. Rather than have empathy for this disabled young man who was being terribly harassed, Mr. Leiderman instead filed a false police report against Joseph Camp, claiming that Joseph Camp sent him a 3,000 page fax. - 20. Mr. Leiderman filed court papers in two court cases where I am not a party, trying to have me held in contempt of court by claiming I am in a conspiracy to kill him. The names of the cases where Mr. Leiderman filed these papers are Via View v Retzlaff and Via View v Camp. Both of these were workplace violence TRO cases against men who had never had any contact with Mr. Leiderman, who have stated they have never been to California. In both of those cases, it was obvious Mr. Leiderman's main purpose was to try to control the online free speech of those men. One of these was the aforementioned Joseph Camp and the other was Thomas Retzlaff. Mr. Retzlaff is a man I do not know and with whom I have had no contact.
- 21. LEIDERMAN'S CONSPIRACY THEORIES. On May 12, 2014, Mr. Leiderman went into Superior Court of California, County of Santa Clara, in the case of Via View v Retzlaff. I was not present in court, but later was given a copy of the transcript. Although I am not a party in the case, Mr. Leiderman filed a bizarre court paper trying to have me held in contempt of a court order, although there is no court order against me. Mr. Leiderman was claiming that I was in a conspiracy with Thomas Retzlaff, a man I do not know and with whom I have never had contact. Mr. Leiderman was claiming that we were in a "Manson-like" conspiracy to kill him.

- 22. LEIDERMAN CONSPIRACY THEORY REGARDING THOMAS RETZLAFF: Mr. Leiderman has repeatedly stated, written, and told courts that I am in conspiracy with a man named Thomas Retzlaff. I do not know Thomas Retzlaff and have had no contact with him. There is no conspiracy. I have seen many instances online where Mr. Leiderman has posted hateful statements about Mr. Retzlaff, attributing outlandishly lurid things to him. Since Mr. Leiderman has posted a huge number of lies about me, I do not believe anything he says about anyone.
- 23. LEIDERMAN CONSPIRACY THEORY REGARDING NEAL RAUHAUSER: Mr. Leiderman has repeatedly stated, written and told courts that I am in a conspiracy with a man named Neal Rauhauser. I do not know Mr. Rauhauser. I have seen online that Mr. Rauhauser is an infodata researcher and seems very highly intelligent. I have had a few small professional type interactions online with Mr. Rauhauser. There is no conspiracy. I have also seen online where Mr. Leiderman has posted huge amounts of scurrilous attacks against Mr. Rauhauser, and Mr. Leiderman has written the same sort of slurs in his court filings and spoken them in court. Since Mr. Leiderman has posted a huge number of lies about me, I do not believe anything he says about anyone.
- 24. LEIDERMAN CONSPIRACY THEORY REGARDING JOSEPH CAMP. Mr. Leiderman has repeatedly stated, written, and told courts that I am in a conspiracy with Joseph Camp. Joseph Camp is a young man with special needs, from New York state, who was my legal client for a short time for the limited purpose of addressing a false police report filed against him by Mr. Leiderman. Mr. Camp is not my client now and I have little to no contact with him. During the time Mr. Camp was my client, and at all times, my relationship with Mr. Camp has been of the highest caliber of professionalism and ethics. Mr. Leiderman created and spread lies that Mr. Camp was doing something improper for me for pay. Mr. Camp has never done anything for me and I have never paid him. In dealing with Mr. Camp, I always implored him to follow my lead and block and report people who do wrong, but not to repay them in like kind. He may not always have followed this, but that was the message he always got from me.
- 25. I am in little to no contact with Joseph Camp. I am not his lawyer at this time. I do not pay attention to what Mr. Camp is doing, as it is none of my concern. Mr. Camp cannot be contacted through me. I have at no time had any influence or control over Mr. Camp, though I always try to set a good example by doing what is good and right.
- 26. JOSEPH CAMP'S WEBSITE: Mr. Leiderman also created and spread a lie that I am in control of Joseph Camp's website. This is entirely untrue. Mr. Camp collects documents that he gets through FOIA requests and through research. He posts those on his website. I have only ever been able to see the first page of Mr. Camp's website, because my computer browser is outmoded and is incompatible with the site, so my browser crashes each time I go to the site.
- Mr. Leiderman's belief that I control the site was based on at one time, I thought I had the password for the site and offered to remove something from the site that a person said

bothered them. I told that person to let me know where the item was on the site and IF I could access the site, I would remove it. The person was mistaken, as there was no such item on the site. And as it turned out, I was not able to access the site, since merely going to it crashed my browser. MR. LEIDERMAN was told many times that I have never had access to the website, but he continues to harass me about it and spread lies. ASIDE from which, Mr. Camp's website belongs to Mr. Camp, and it is unclear why Mr. Leiderman should have any concern with it.

- 27. VIA VIEW FILES BLOG. Mr. Leiderman dislikes a blog called Via View Files. That is not my blog. I do not own it, admin it, or write it.
- 28. Mr. Leiderman has a client named James McGibney. Mr. McGibney runs a corporation called Via View. In my opinion and by observation, Via View runs an extortion racket. McGibney runs a revenge porn website called Cheaterville.com where he posts the often-compromising photos of people, along with scurrilous writings about them. The victims of the site are then supposed to pay extortion fees of hundreds of dollars to have their photos and listings removed.
- 29. James McGibney also runs a hate speech/extortion site called Bullyville.com. Mr. McGibney has posted huge amounts of defamation against me, and invasions of my privacy, stalking, harassment, etc. on his Bullyville.com site. Mr. McGibney also has tweeted many sexual and stalking and taunting tweets at me.
- 30. Mr. McGibney purchases domain names in the names of people he is harassing or trying to extort. Mr. Leiderman appears to approve of and encourage this method of harassment by Mr. McGibney. In my name, Mr. McGibney owns Suebasko.com, suebaskolaw.com, and disbarbasko.com. He uses these to defame, denigrate, demean, and to try to extort me.
- 31. LEIDERMAN AND MCGIBNEY ASSOCIATE WITH MALICIOUS PEOPLE ONLINE. Mr. Leiderman and Mr. McGibney associate online with two particularly malicious people. One of these people uses the sock puppet names of @CattyIdiot, who runs a racist radio show called "Tea Time for Jew and Me," and engages in a huge amount of racism, anti-Semitism, sexism, ageism, and constant, shockingly malicious attacks against others. The other associate of Mr. Leiderman and Mr. McGibney uses the name "Captien Obvious" or "Captien 007." Both of these unnamed individuals have stalked and harassed me, engage in a constant effort to try to get me to lose my law license and undermine my work. "Captien Obvious" wrote and posted a ludicrous, unsigned bar complaint against me and Mr. Leiderman filed it, though claiming not to know who Captien Obvious is.
- 32. ASIDE from the above-named two extremely malicious people, Leiderman and McGibney also associate with many other malicious people from the hacker group Anonymous, the hacker-fraudster group Rustle League, and McGibney's harassment-vigilante gang called Bullyville. I want NO contact from or connection with such people

and I block them, ignore them, and report them to social media abuse departments when needed.

- 33. NEVER HAD CONTACT WITH MCGIBNEY, CATTY IDIOT, OR CAPTIEN OBVIOUS. I have never met, contacted, responded to, or engaged in any sort of contact or reaction to Mr. McGibney or his associates, Catty Idiot or Captien Obvious. This is true, despite the ongoing, horrifically vulgar, sickening, disgustingly sexualized filth, attacks on my character, attacks on my work, denigrations against me, posted continuously by these perverts online. I simply report them to social media, report them to authorities, block them, and ignore them.
- 34. MY PRIVATE EMAILS POSTED PUBLICALLY ONLINE. Mr. Leiderman got ahold of a good number of my private personal and legal emails. Each one was marked with a privacy notice. Mr. Leiderman immediately posted my emails online for all the world to see. So did Mr. McGibney, CattyIdiot, and Captien Obvious. ALL of these emails were of a deeply private nature. When I asked Leiderman and McGibney to stop posting my emails, they posted more and mocked me.

When I wrote an email to Paul Gianni, a lawyer in Texas doing some work for McGibney's revenge porn/extortion company, Via View, and asked him to please get Leiderman and McGibney to take my private emails down from public view, Leiderman and McGibney posted that email.

When I wrote an email to a Via View Board member, Scott Corey Ryan, who is also licensed in Illinois and who may have been my law school classmate, to please have them remove my private legal and personal emails from public display, Leiderman replied to me and to Mr. Ryan calling me mentally ill and a terrorist.

They are all based on wild conspiracy theories, trying to tie together random people on the internet, and sock puppet twitter accounts, and lots of unknown "Does" into these giant grand conspiracies supposedly against Leiderman and McGibney.
- 38. LEIDERMAN TYING ME TO HIS CONSPIRACY THEORIES. Because, as I have stated repeatedly, I do nothing to Mr. Leiderman or Mr. McGibney, they have created wild conspiracies where they claim I am in (nonexistent) conspiracies with men to whom they attribute all sorts of lurid things. I don't do anything, so Leiderman tries to claim I

do something by linking me by conspiracy to men whom Leiderman denigrates, although I don't think those men are doing anything wrong, either.

- 39. EXTREME DAMAGE TO ME. The stalking and harassment I have endured from Mr. Leiderman, Mr. McGibney, and their associates "Catty Idiot" and "Captien Obvious" have been extreme. My health and well-being have been extremely damaged. My work has been extremely damaged. My relationships have suffered. These are very evil men.
- 39. NO EVIDENCE: PLEASE NOTE THAT there is no evidence against me, since I have done nothing. This is why Mr. Leiderman concocted these crazy conspiracy theories—to try to connect me to imagined wrongdoings of men about whom he has created lurid tales. There is no conspiracy.
